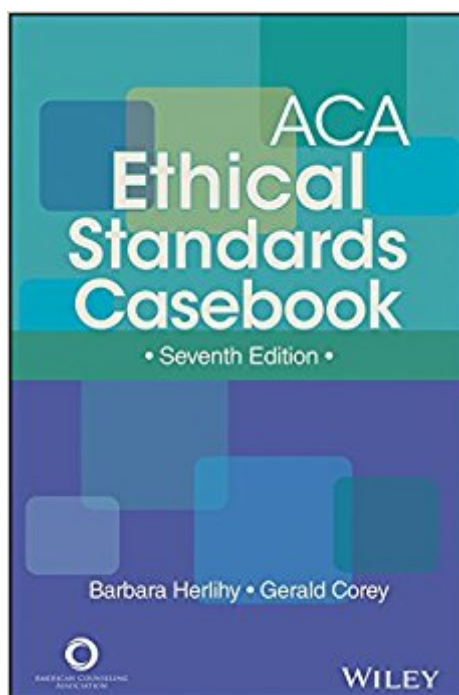

I ordered this book for a class at my school. The book is great and I only have one complaint, the Kindle for iPad "e-textbook" has no page numbers, and I can't cite a resource without page numbers. Luckily the book is entirely codified with word for word text directly from the ACA standard.

I can simply cite the code, but if I wanted to use a portion of the case example, I cannot. The best way I found to overcome the lack of page numbers is by searching the index and finding the page on which the topic of interest is listed. So overall, I'm happy with the book, but I wish I bought the paperback due to the aforementioned situation. I might suggest for kindle on iPad to add page numbers to the location slider and search tool.
